The agreement allows for the draw down of up to AUD 1 million in tranches as required over 12 months. Any funds drawn down will convert to CDI's in the Company at a price equal to a 15% discount to the 10 - day volume weighted average price of the Company's securities. The issue of shares pursuant to draw downs is not subject to shareholder approval.</p> <p>The Company made its full drawdown of AUD 1 million on 6 January 2021 and completed the issue of 1,463,734 CDIs.</p>
