#### **Cleansing Notice / Appendix 2A**

European Metals Holdings Limited ("European Metals" or "the Company") (ASX & AIM: EMH, NASDAQ: ERPNF) advises that it has completed the issue of 6,454,546 CDIs to institutional and sophisticated investors announced on 3 February 2021 at \$1.10 per CDI to raise \$7.1 million.
